Bookings that include all, or any part, of 22nd December to 2nd January require a (non-refundable) deposit of £50 to be paid at the time of booking.

★ ONLY FULLY VACCINATED DOGS WILL BE ACCEPTED. ★

★ DO ENSURE ALL VACCINATIONS, INCLUDING KENNEL COUGH, ★

★ ARE COMPLETED AT LEAST 2 WEEKS PRIOR TO ARRIVAL, OR BOARDING WILL BE REFUSED. ★

No responsibility is taken for loss, escape or sickness of any dog whilst at the kennels, or during the transport to and from there. Nor for any of the owner's property which is brought with the dog(s). In the event of any dog becoming ill, treatment will be charged for. All boarding fees and expenses which may arise must be paid in advance, or before the dog(s) leave the kennels. In the event of any dog not being collected and the boarding fees due not being paid within a reasonable period, the dog(s) will be considered as abandoned.

DOGS ARE ACCEPTED FOR BOARDING ONLY AT OWNERS RISK.

CANCELLATIONS: THE WHOLE PERIOD BOOKED WILL BE CHARGED UNLESS 3 WEEKS WRITTEN NOTICE OF CANCELLATION IS GIVEN.

Please note: Day of arrival and departure will be charged for.

Minimum 5 day period will be charged over Bank Holidays and during July, August and Christmas holidays.
